CONDITIONS OF USE

- 1 The Carer agrees to accept Childcare Vouchers from parents as full or part payment for the childcare specified overleaf.
- 2 The Expiry Date stated must not have been exceeded when they are received for redemption by CO Ltd.
- 3 Childcare Vouchers can not be used to pay for any other goods or services other than childcare as stated overleaf.
- 4 Responsibility for meeting statutory childcare regulations rests with the Carer.
- 5 Responsibility for the safety of any Childcare Vouchers posted to CO Ltd. rests with the Carer until they are received by CO Ltd. The Carer should retain the counterfoils for each voucher and Voucher Claim Form in case there is a query.
- 6 A separate Voucher Redemption Agreement is required for each parent who pays you for childcare services with Childcare Vouchers.
- 7 Payment for the Childcare Vouchers will be made into the Carer's bank account.
- 8 If incorrect bank details are quoted to CO Ltd., CO Ltd reserves the right to charge a fee to cover any costs incurred in correcting any incorrect payments made.
- 9 If the Carer wishes to change the bank account into which the payments are made, a written advice should be sent to CO Ltd., giving at least 10 working days notice.
- 10 Subject to the terms and condition of this agreement being met, CO Ltd. will send payment to the stated Carer's bank account by BACS transfer.
- 11 The payment will be made subject to completion of a BACS Payment Agreement.
